### Qualifications for applicants:

- 1 Applicants should finish 12-year education or reach the equivalent education level in your home country.
- 2 Applicants should have a purpose of study and also detailed plans after he or she graduate from the Japanese language school.
- 3 Applicants must complete at least 150 hours of Japanese language course in their home countries and pass the N5 level of Japanese proficiency tests. (ex. JLPT, NAT-TEST, J-TEST). Notice: TOP-J, J-CERT and JLCT are not qualified.

### The period of Study:

**April admission:** April 2022 – April 2024 (2-year course)

Holidays: Saturdays, Sundays, national holidays and school holidays.

### School Hours:

Mondays ~ Fridays 5 days a week

Morning class: 09:00 ~ 12:50

Afternoon class: 13:10 ~ 17:00

### Refund Policies

- ① (\*) The following fees will be deducted from the tuition fee payment in case of VISA refusal and cancellations. Admission fee (20,000 JPY) + Registration fee (50,000 JPY) will be deducted from the tuition fee and the remaining balance will be refunded to the provided student's bank account. Tuition fee refund transaction fee charges must be paid by the student.
- ② Tuition fees that are already settled are non-refundable for any reason (temporary leave, course withdrawal, etc.) after enrolling.

### **Application period:**

Once the vacant for admission are already filled, the application will be closed.

Note: Please apply or inquire to our school in advance.

### **How to apply:**

STEP 1: Applicants must send the required documents in data format (PDF recommended) to the admission staff via email.

STEP 2: Interview screenings are conducted after the document screenings. Overall results will be notified to the applicant after the process are completed.

STEP 3: After processing all the required documents for Certificate of Eligibility application, Nagoya SKY Japanese language school will apply for the Certificate of Eligibility on behalf of the applicant.

STEP 4: Once the application has been processed and submitted to the Immigration, applicants will receive an individual notification regarding the application. Also, our school will notify each applicant's application results once they are out from the Immigration.

STEP 5: Once the Certificate of Eligibility is issued, our school will send the original hard copy documents including the permit of admission, and other documents that belongs to the applicant.

### **Admission/ Application procedure:**

① Document screenings ➡ ② Interview ➡ ③ Result announcement  
➡ ④ COE application

Note: The application procedure will be conducted in the above-mentioned order.

The admission results will be notified to the applicants. Applicants who successfully passed the admission, will be receiving "Admission certificate".

## Documents for Applications of Language Students

1. The graduation diploma with the transcript of your final school of Education. (Student who have graduated from training school for the 12-year academic will be strictly examined.)
2. The certificate of your Japanese study more than 150 hours from the school (issued by the school in your country) and the qualification of Japanese tests with the transcript. (ex. JLPT, NAT-TEST, J-TEST N5 level or higher). ※TOP-J, J-CERT and JLCT certificates are not qualified
3. Your resume (specified by our school)
4. Medical check-up documentation (specified by our school)
5. Copy of your passport or any other substitutes
6. 5 photos (4.0x3.0cm) (taken within three months)
7. Documents regarding the ability of paying your tuition and expenses at our school by your parents, relatives or persons residing in Japan
  - a. A deposit of US\$15,000 to 30,000 or about the same amount in your country currency
  - b. The copy of the account book with the last 3 year-details
  - c. The sponsor's tax certificate or income certificate
  - d. The sponsor's statement of paying your expenses (specified by the immigration department)
8. The certificate of the relationship between you and the sponsor

- Note: ① The application documents vary according to the applicant's country. Please call or e-mail the school for further information.
- ② Please write the name who photocopied the documents, the date of the documents was copied and also the relationship between the person who copied the documents and the applicant in the spare space of the copies.

【Providing the agent's or school's name on the application form】

Starting from year 2018<sup>th</sup>, Nagoya Regional Immigration Bureau has required Japanese language schools to provide any information of the agencies or schools in the application form. Our school may require agencies, Japanese language schools or consultancies to provide company's certificates listed below:

【Study abroad agency permits, Business certificates, Permit/ Certificate issued from the Department of Education etc.】

Applicants with nationalities above may required complex documentation or additional documents depending on the immigration's request.

【Charged fees after enrollment】

During the 1<sup>st</sup> year course, students are not required to pay any additional fees.

Student's will be only charged 3 months before the 2<sup>nd</sup> year approaches. 2<sup>nd</sup> year tuitions must be fully settled one month before the 2<sup>nd</sup> year starts.

- April course ➔ **Due date: End of March**

Invoice letter will be distributed to students on December.

- July course ➔ **Due date: End of June**

Invoice letter will be distributed to students on March.

- October course ➔ **Due date: End of September**

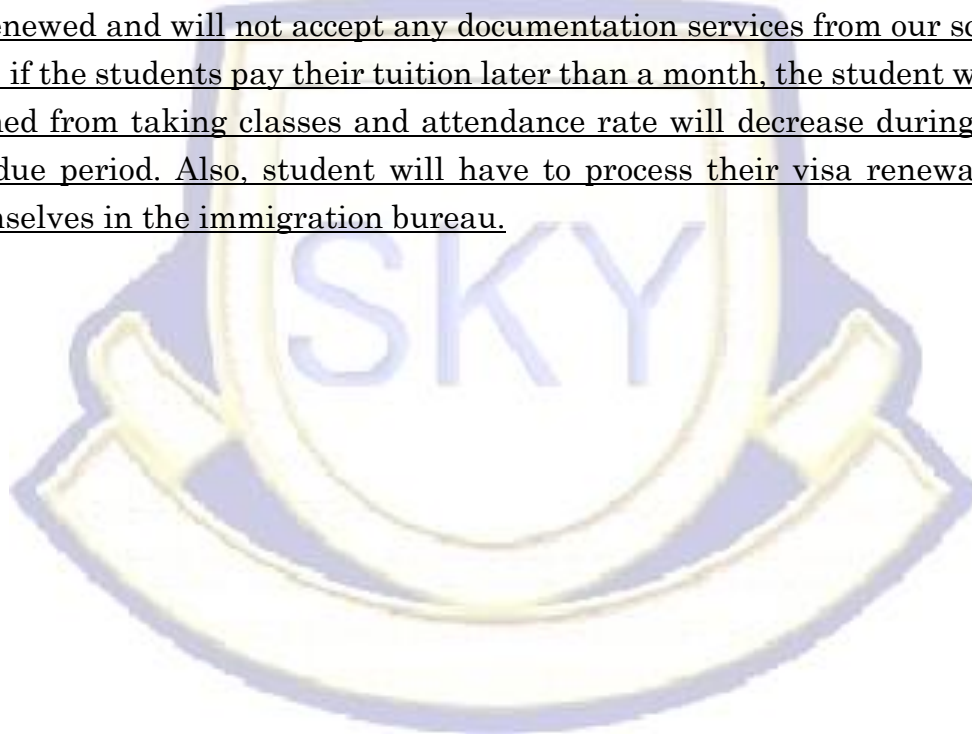
Invoice letter will be distributed to students on June.

- ※ If students have overdue payments/ outstanding payments in tuitions, students are not allowed to attend any classes.
- ※ There will be no exception in case of any unattended classes during the above-mentioned period. Students will be marked as “absent”.

**IMPORTANT: We do not accept any installments in tuitions.**

Most of the students misunderstood that we allow installments in tuition, however, **we only accept full payments.**

Note: If students do not pay in full amount of tuition, student’s visas will not be renewed and will not accept any documentation services from our school. Also, if the students pay their tuition later than a month, the student will be banned from taking classes and attendance rate will decrease during that overdue period. Also, student will have to process their visa renewals by themselves in the immigration bureau.





## Notice regarding school dormitories

This letter is to notify that our school dormitory will no longer be available for new residents and will permanently close from July 2021.

Starting from July 2021, our school will change the accommodation system from school dormitory to providing information of possible real estate company that accept international students. We will provide information and details of accommodation after consulting with the students.

### **【Procedure】**

- ① Take survey
- ② Search for possible real estate
- ③ Provide information of real estate company

★ Our school will be only providing information and details regarding real estate company. After providing the information regarding accommodation, students have to make appointment with the real estate company staff for the details of the accommodations.

★ Students who have already placed their payments for accommodation (year 2020 applicants) will be still receiving support regarding the replacement of accommodation from school dormitory.

→ We will be contacting the student regarding the accommodation.

## **Information about proceeding to higher education after graduation**

In recent years, higher education institutes (vocational schools, universities etc.) have been setting the admission standards higher to students who are planning to apply to enter. One of the most strictly monitored is the students who have tattoos.

Majority of schools that NOT accepting students with tattoos are especially,

- Automobile vocational schools (automobile mechanic)
- Travel and tourism vocational / training schools
- Medical schools, universities (Caregiving / nursing etc.)
- Nursery training / vocational schools
- Vocational schools/ Universities for teaching
- Business schools

All institutes mentioned above are not accepting applications from students who have tattoos.

As most people know that Japan is a society that is not fully open (strict) about tattoos. Therefore, students with tattoos will have more disadvantage in applying for higher institutes and companies. Please make sure applicants are aware about the recent regulations of higher education institutes regarding students with tattoos. Also, our school will not take any responsibilities if students fail to apply for any institutes.
